
The Republic of India/ Government of Nagaland has received financing from the International
Fund for Agricultural Development ("the Fund" or "IFAD") towards the cost of FOSTERING
CLIMATE RESILIENT UPLAND FARMING SYSTEMS IN NORTH
EAST (Nagaland) ("the client" or "procuring entity"), and intends to apply part of the proceeds
for the recruitment of consulting services, for which this REOI is issued.

The use of any IFAD financing shall be subject to IFAD's approval/no objection, pursuantto the terms and conditions of the financing agreement, as well as IFAD's rules, policies and procedures. IFAD and its officials, agents and employees shall be held harmless from and against all suits, proceedings, claims, demands, losses and liability of any kind or nature brought by any party in connection with FOSTERING CLIMATE RESILIENT UPLAND FARMING SYSTEMS IN NORTH EAST (Nagaland).

This request for expressions of interest (REOI) will be advertised in Nagaland Post & Times of India and Assam Tribune newspaper and on the project website www.focus.nagaland.gov.in.

2. The client now invites expressions of interest (EOIs) from consulting firms/Agency (not individual consultants) ("consultants") for Endline Survey for FOCUS-Nagaland.

More details on these consulting services are provided in the preliminary terms of reference (PTOR) attached as Annex 1. The Consulting Agency expressing interest for the assignment should refer Annex 1 for the minimum eligibility conditions.

- 3. Before preparing its EOIs, the consultant is advised to review the preliminary terms of reference attached as Annex 1, which describe the assignment and Annex 2 that details the evaluation of the technical qualifications.
- 4. The consultant shall not have any actual, potential or reasonably perceived conflict of interest. A consultant with an actual, potential or reasonably perceived conflict of interestshall be disqualified unless otherwise explicitly approved by the Fund. A consultant including their respective personnel and affiliates are considered to have a conflict of interest if they a) have a relationship that provides them with undue or undisclosed information about or influence over the selection process and the execution of the contract, b) participate in more than one EOI under this procurement action, c) have a business or family relationship with a member of the client's board of directors or its personnel, the Fund or its personnel, or any other individual that was, has been or mightreasonably be directly or indirectly involved in any part of (i) the preparation of this expression of interest, (ii) the selection process for this procurement, or (iii) execution of the contract. The consultant has an ongoing obligation to disclose any situation of actual, potential or reasonably perceived conflict of interest during preparation of the EOI, the selection process or the contract execution. Failure to properly disclose any of said situations may lead to appropriate actions, including the disqualification of the consultant, the termination of the contract and any other as appropriate under the IFAD Policy on Preventing Fraud and Corruption in its Projects and Operations².
- 5. All consultants are required to comply with the Revised IFAD Policy on Preventing Fraudand Corruption in its Activities and Operations (hereinafter, "IFAD's Anticorruption Policy") in competing for, or in executing, the contract.
 - a. - (iii) receive the proceeds of any loan or grant provided by the Fund. The Fund also has the right to recognize debarments issued by other international financial institutions in accordance with its Anticorruption Policy.
- c. Consultants and any of their personnel and agents, and their sub-consultants, sub-contractors, service providers, suppliers, sub-suppliers and any of their personnel and agents are required to fully cooperate with any investigation conducted by the Fund, including by making personnel available for interviews and by providing full access to any and all accounts, premises, documents and records (including electronic records) relating to this selection process or the execution of the contractand to have such accounts, premises, records and documents audited and/or inspected by auditors and/or investigators appointed by the Fund.
- d. Consultants have the ongoing obligation to disclose in their EOI and later in writing as may become relevant: (i) any administrative sanctions, criminal convictions or temporary suspensions of themselves or any of their key personnel or agents for fraud and corruption, and (ii) any commissions or fees paid or to be paid to agents or other parties in connection with this selection process or the execution of the contract. The Fund requires that all beneficiaries of IFAD funding or funds administered by IFAD, including the client, any consultants, implementing partners, service providers and suppliers, observe the highest standards of integrity during the procurement and execution of such contracts, and commit to combat money laundering and terrorism financing consistent with IFAD's Anti-Money Laundering and Countering the Financing of Terrorism Policy.⁴
- 7. Procedure: the selection process will be conducted using Selection Based on Consultant Qualification (CQS) as laid out in the IFAD Procurement Handbook that can be accessed the IFAD website at www.ifad.org/project-procurement.
- 8. The client will evaluate the EOIs using the criteria provided in Annex 2. The shortlisted consultant(s) will be provided with the detailed TORs and asked to submit a detailed technical and financial offer. The evaluation will include a review and verification of qualifications and past performance, including a reference check, prior to the contract award.





Terms of Reference (ToR) for Conducting Endline Survey for FOCUS-Nagaland Ref: No: APC/FOCUS/E. S/149/2024.

Title: "Endline Survey for FOCUS-Nagaland"

Client 1.

The client for this assignment is Society for Climate Resilient Agriculture in Nagaland (SoCRAN).

Country background 2.

Nagaland is one of the eight states in the North Eastern Region (NER) of India, a biodiversity hotspot where climate change adaptation is of critical importance for the largely rural population. With a hilly terrain, low population density, shallow soils and high rainfall, farmers have adopted a shifting cultivation system known as jhum. This largely self-sufficient system has adequately met the various needs of rural communities, including food, fibre and energy, but is now getting disrupted due to shortening jhum cycles as a result of increasing population, focus on high value crops for cash income, soil fertility degradation and top soil erosion on account of decreased fallow cycles. Changing climate patterns is further exacerbating these disruptive trends.

Background on project- Fostering Climate Resilient Upland Farming Systems in the North East

The International Fund for Agriculture Development (IFAD) is financing in the form of loan and grant to the borrower, the Republic of India for the purpose of implementing the project Fostering Climate Resilient Farming System in the North East- Nagaland (FOCUS- Nagaland). A financing agreement has been signed between IFAD and the borrower; the Republic of India dated 25th January 2018.

The overall objective of the project is "To increase agricultural income of 118,000 households and to enhance their resilience to climate change". This would be achieved through the development objective of increasing the environmental sustainability and profitability of farming systems practiced by highland farmers.

Jhum cultivation and the traditional foods that it produces are the cornerstones of the tribal cultural heritage and identity in Nagaland. The project envisions intervention on the current farming systems and livelihood practices, and making this system more productive and sustainable.

FOCUS- Nagaland covers 645 villages in 8 districts in the state and with an additional district with the reformation of new districts in the State. The districts covered under the project are Zunheboto, Mokokchung, Wokha, Phek, Longleng, Mon, Kiphire and Kohima including Tseminyu District which was previously covered under Kohima.

The project has three components namely:

- I. Improved farmers capacities to manage upland farming sustainably
- II. Value Chain & Market Access
- III. Project Management & Knowledge services

4. Overall objectives of the project

The overall objective of the project is, "To increase agricultural income of 118,000 households and to enhance their resilience to climate change". This would be achieved through the development objective of increasing the environmental sustainability and profitability of farming systems practiced by highland farmers.

FOCUS-Nagaland covers 645 villages in 8 (Eight) districts in the state. The districts covered under the project are Kohima, Zunheboto, Mokokchung, Wokha, Phek, Longleng, Kiphire, and Mon. The project is expected to be completed by 31st March 2024.

5. Background of the assignment

The End line Survey is a comprehensive household survey that is to be undertaken at the end of the project. This aims to provide information about results that has been achieved during project implementation. In particular, the End Line Survey is intended to set out to identify positive and negative changes taking place at the household level. These changes will be measured relative to the baseline study, which was conducted at the beginning of the project. The study aims to cover all districts covering 3540 households selected randomly from 407 project villages.

6. Objectives of the assignment

The objective of the assignment is to evaluate the project achievements against the project targets. The End Line Survey to assess the achievements by comparing with the Baseline Survey that was conducted at the start of the project in 2019 by FAO covering Eight districts. The baseline survey covered 3232 randomly selected households in 388 sampled villages.

The assignment will study the changes relative to the baseline survey as well as the project target which is given in the project log frame. The endline survey will study the achievement of the log frame indicators such as the outreach, output and outcome. The detailed terms of reference will be provided to the shortlisted agency for preparing combined technical and financial proposal.

9. Key Qualifications and Experience of the Agency

The consultant agency should have an independent legal existence, registered under the applicable Act. [Submit proof of Registration Certificate, Articles and Memorandum of Association]. It will be evaluated based on the following experience and qualifications.

Sl. No	Description
1	The firm should have prior experience & expertise in designing experimental and quasi-experimental Impact Evaluation Designs in last 5 years. Partially completed assignments will not be taken into consideration. In particular, experience in randomized evaluations, quasi experiment evaluations or evaluations using statistical methods is mandatory. Preference will be given to agencies that have successfully completed at least 1-2 impact evaluations of externally aided projects.
2	Availability of expert team members in the firm with prior experience & expertise in designing experimental and quasi-experimental Impact Evaluation Designs in last five years. Preference will be given to agencies that have full time staff which have done impact evaluations using scientific statistical methods.
3	The firm should have a successful track record of supervising or implementing large-scale household surveys (>4000 HHs) of nation-wide/ inter-state/ state-wide development projects funded by GOI or State governments other sector during the last 3 years. Preference will be given to agencies with past experience in social sector/ development project in the north eastern part of India.
4	The firm should have an annual average turnover of Rs. 1.00 Crore or more during last three financial years and preferably a positive net worth. Out of the total turnover, at least Rs. 50 lakhs should be from Impact evaluation or other monitoring studies. Relevant documents viz, audited financial statements and a certificate from Charted Accountant in support of satisfying the criteria should be submitted.
5	The firm should not have been blacklisted or debarred from public procurement by any Central Government Departments, State Government Department/agencies, Public Sector Undertakings or externally aided projects. A self-declaration in appropriate non-judicial stamp paper value and notarized should be attached. Please be advised that suppression of information of blacklisting or debarred will render the proposal rejected.

13. Location and period of execution

The assignment is expected to be completed within 105 days with effect from the date of signing of the contract agreement.
